It offers a way to improve both adherence and affordability for employees taking eligible medications for chronic conditions like diabetes and respiratory diseases. Once enrolled, they get SMS reminders when it's time to refill. The more they refill on time, the lower their copay at the pharmacy. A typical member will save an average of 45% on their out-ofpocket costs — totaling around \$230 a year.<sup>6</sup>

# **Utilization Management (UM)**

- Quantity limits promote safe, cost-effective medication use by controlling how often or how much of a drug can be filled at once.
