The purpose of this document is to direct Healthy Blue + Medicare providers to the appropriate section of the *Medical Policy* and *Clinical Utilization Management (UM) Guidelines* website in order to find the appropriate documentation that applies to Healthy Blue + Medicare.

5	To search for a specific <i>Medical Policy</i> or <i>Clinical UM Guideline</i> , use the <b>Search by keyword of code</b> function at the bottom of the page.
