HCC Risk Adjustment Reference Coding Guide

#### Acute and History of Myocardial Infarction



A quick reference guide to assist with accurate, complete documentation and coding that reflects the true nature of a patient's current health status at the highest level of specificity. Per ICD-10 official guidelines for reporting and coding.

The importance of consistent, complete documentation in the medical record cannot be over-emphasized. Without such documentation, accurate coding cannot be achieved.

### Acute Myocardial Infarction vs. History of MI

I21 is a non-specific and non-billable diagnosis code.

Non-specific codes like I21 require more digits to indicate the appropriate level of specificity. Consider using any of the following ICD-10-CM codes with a higher level of specificity when coding for acute myocardial infarction.

ICD 10 code	Description	Coding Guidance	Examples of when to use
<b>I21.x</b> CMS HCC (v.24 86) (v.28 228) HHS HCC 131	STEMI and NSTEMI (Acute)	MI specified as acute or with a stated duration of <b>4 weeks (28 days) or</b> <b>less</b> from onset.	Member hospitalized on 5/2/21 for Acute Non-ST elevation MI. Seen by PCP for a follow-up visit on 5/20/21.
I22.x CMS HCC (v.24 86) (v.28 228) HHS HCC 131	Subsequent MI	Acute MI occurring within 4 weeks (28 days) of a previous acute MI. Only report a code from category I22- if the initial and the subsequent MI are type 1 or unspecified. If the subsequent MI is not type 1 see I21.A1 or I21.A9. If a subsequent myocardial infarction of one type occurs within 4 weeks of a myocardial infarction of a different type, assign the appropriate codes from category I21 to identify each type. Do not assign a code from I22.	Member experienced a subsequent non- ST elevation MI less than 3 weeks after the onset of the previous event.
125.2 No HCC	Old MI	Healed or past MI diagnosed by ECG or other investigation, currently presenting no symptoms.	Member had MI in 2007

#### Acute MI occurring within **4 weeks (28 days)** of a previous acute MI/

ICD 10 code	Description
122.0	ST elevation (STEMI) myocardial infarction involving left main coronary artery
122.1	ST elevation (STEMI) myocardial infarction involving left anterior descending coronary artery
122.2	ST elevation (STEMI) myocardial infarction involving other coronary artery of anterior wall.
122.8	ST elevation (STEMI) myocardial infarction involving right coronary artery
122.9	ST elevation (STEMI) myocardial infarction involving other coronary artery of inferior wall

#### **History of Myocardial Infarction**

ICD 10 code	Description
125	Chronic ischemic heart disease is a non-specific and <b>non-billable diagnosis code</b>
125.2	<ul> <li>Old myocardial infarction (MI occurred &gt; 28 days ago) Inclusion Terms: Healed myocardial infarction</li> <li>Past myocardial infarction diagnosed by ECG or other investigation, but currently presenting no symptoms</li> </ul>
