

# NATIONAL GRID+ DENTAL NETWORK

#### What is the GRID+ network (GRID+)?

GRID+, administered by the GRID Dental Corporation (GDC), is a national dental network and includes many of the nation's Blue plans. In addition, GRID+ coordinates access to networks wherever local Blue plans do not participate.

## How does this impact a Blue Cross and Blue Shield of North Carolina (Blue Cross NC) participating provider?

If you are a participating provider with the Blue Cross NC dental network, you are automatically included as a participating provider in GRID+ network.

When members of other participating Blue plans who are in North Carolina are searching for a participating dental provider, your practice will appear in the provider directory. This may assist you in growing your practice, should those members choose you as their dental provider.

In order to verify that a member of an out-of-state Blue plan qualifies as a "member" under your agreement, look for a "GRID+" indicator on the member's Blue Cross and/or Blue Shield branded card or on the notification of payment. Claims processing, benefits and customer service for these members will be handled by the out-of-state Blue plan that issued the card to the applicable member, so please use the information on the back of the member's ID card as you currently do.

#### What fee schedule applies?

As a North Carolina provider, regardless of whether the patient is a Blue Cross NC member or a member of another participating plan, the fee schedule contracted under the Blue Cross NC agreement applies.\*

#### Who should I contact for claim issues?

Contact the company listed on the member's ID card or Explanation of Payments (EOP) for questions or issues related to a specific claim. Please be sure to get a representative name and reference number related to your call. Should the plan be unable to adequately answer questions about your contracted fee amount, please contact the Blue Cross NC Provider Service department at **1-800-777-1643**, **Option 6**.

GRID Dental Corporation is an independent company that provides access to dental networks and services on behalf of Blue Cross NC.

\* Certain Blue Cross and Blue Shield plans may own their own national dental network (e.g., DeCare and UniCare are owned by Anthem; Dominion is owned by Capital BlueCross; DenteMax is owned by HCSC). Should you separately contract with those networks, the respective Blue Cross and Blue Shield plan may choose to apply the contracted rate under their owned network.
